Biological Resources

- Federally Listed Species Range
 - o Monarch Butterfly – Proposed Threatened
 - o Piping Plover – Threatened
 - o Regal Fritillary – Proposed Threatened
 - o Whooping Crane – Endangered
- State Listed Species Range
 - o Northern Long-Eared Bat – Endangered
 - o Whooping Crane – Endangered
- **No** critical habitat identified

Water Resources

- Plum Creek is a 303d water body
 - o Impaired for aquatic life, cause unknown
- Elwood Reservoir is a 303d water body

- Impaired for aquatic life, caused by mercury
- The DPA has two Wellhead Protection Areas
 - Village of Smithfield (NE3107313)
 - Village of Elwood (NE3107308)

Classified Lands

- There is one NGPC property within the DPA
 - Elwood Reservoir WMA
- There is one Federal Real Property within the DPA
- There is one Federal Permitting Areas within the DPA
