
1. Open the FEMA Flood Map Service Center. Enter an address, place, or coordinates in the search bar at the top.

2. Once your project area has been located on the map, download the **Firmette Map**. Depending on your project location, FEMA will give you different options to do this.
  - a. Select **DYNAMIC MAP - PRINT MAP/FIRMette** above the map. This will take you to a new browser tab. Once there, you can download the FIRMette map to your desired folder.




