Water Resources

- Scout Creek is a 303d water body
 - o Impaired for aquatic life, cause unknown
- Ditch No. 2 is a 303d water body
 - o Impaired for recreation use, caused by pathogens
- East Hershey Lake (WMA) is a 303d water body
 - o Impaired for aquatic life, caused by mercury
- Fremont Slough is a 303d water body
 - o Impaired for aquatic life, cause unknown
- The DPA has **no** Wellhead Protection Areas

 - o East Hershey WMA
