Water Resources

- North Platte River is a 303d water body
 - Impaired for aquatic life, caused by temperature
- Lake Ogallala is **not** a 303d water body
 - Impaired for aquatic life, caused by algal growth, nutrients, oxygen depletion
- Unnamed Creek is a 303d water body
 - Impaired for aquatic life, cause unknown
- East Sutherland Lake (WMA) is a 303d water body
 - Impaired for aquatic life, caused by mercury
- Sutherland Outler Canal is a 303d water body
 - Impaired for aquatic life, caused by fish consumption advisory
- The DPA has one Wellhead Protection Area
 - City of Ogallala (NE3110102)

Classified Lands

- There are five NGPC properties within the DPA
 - Lake McConaughy SRA
 - Lake Ogallala SRA
 - East Sutherland WMA
 - North River WMA
 - Muskrat Run WMA
