  - o Impaired for aquatic life, caused by algal growth, nutrients, oxygen depletion
- Unnamed Creek is a 303d water body
  - o Impaired for aquatic life, cause unknown
- East Sutherland Lake (WMA) is a 303d water body
  - o Impaired for aquatic life, caused by mercury
- Sutherland Outler Canal is a 303d water body
  - o Impaired for aquatic life, caused by fish consumption advisory
  - The DPA has one Wellhead Protection Area
    - City of Ogallala (NE3110102)
