#### Water Resources

- There are impaired waters within the DPA
  - Soldier Creek is 303d listed, impaired for Public Drinking Water Supply
  - Lake Carter P. Johnson (Ft. Robinson State Park) is 303d listed, impaired for Aquatic life
- The DPA has **no** Wellhead Protection Areas

- There are two NGPC properties in the DPA
  - Fort Robinson SP
  - Fort Robinson WMA
- There is one USFS property in the DPA
  - Nebraska National Forest
- There are Bureau of Land Management properties in the DPA
  - 4 properties
