In other news, Initial Proposal Volume 2 (IPV2) has been posted to our website. Sections highlighted in red reflect corrections submitted to NTIA, which are pending approval. While we expect approval soon, we wanted to share the document now given the strong interest and many inquiries. We're also getting close to finalizing our NBEAD eligible inventory. NTIA tells us we're at the finish line with the challenge process data, and once that's done, we'll be able to publish the Defined Project Areas (DPAs). It's a big step, and one that we're anxious to take.

Our RFA is under legal review now and we are working with Submittable to set up and test the application portal. If all goes as anticipated, we're aiming to open applications in the next month or two. For a breakdown of the timeline, flip to page 2!

#### **Engagement**

This fall, our office has prioritized outreach to areas that will be most impacted by the NBEAD program. Our efforts concluded in a statewide circuit of 12 cities, where we shared updates about our work, the anticipated impact of NBEAD, and ways to collaborate to ensure the success of bringing high-speed internet to all Nebraskans.

A key focus of these discussions was preparing local officials for the expected increase in right-of-way permitting applications once subgrants are announced. We also highlighted information regarding pole attachments: a significant number of utility poles across Nebraska either need replacement, lack space for additional lines, or cannot structurally support more lines. This critical insight will have substantial implications for project planning and costs.



# **Digital Equity Update**

We are thrilled to announce that NBO was notified by NTIA on November 21, 2024, that we were awarded \$6.5M in Digital Equity Capacity 2024 (DECAP4) funding. This is the first of three anticipated installments of digital equity capacity funding.

NBO's plan is to subgrant most of this funding out to communities – where it can do the most good. The 2024 funding will be used to support projects targeting goals 1, 4, and 5 of Nebraska's Digital Equity (DE) Plan, which is available at

https://broadband.nebraska.gov/digital-equity/.

Watch our website for a DECAP4 Request for Applications anticipated in early March 2025.

Between now and then, DE staff will be working with a contractor to spread the word about the availability of funds and meeting with potential subgrantees to talk through ideas and possibilities. DE staff also want to offer technical assistance – tips for writing a successful application – while we can do so.
